
Simplified system for clients




#### My Inspection

## Overview of KR EDAS V2



KR EDAS V2 provides online drawing approval for ships and equipment drawings to reduce the time and cost of post for drawing approval requests, and has enhanced functions such as Revision Management and Comment Reply to maximize customer convenience,

In addition, KR EDAS V2 reveals the drawing approval process transparently so that customers can see the drawing approval status overall, so as to ensure the reliability of classification work and contribute to the management of the customer's schedule.

## **Special Features**

1) You can check the status of all drawings (during construction/after construction/ conversion of existing vessel/IHM, etc.) and the approval and comments status approved by Korean Register through the dashboard, and drawing approval details are provided for each vessel.




2) The time and costs of processing drawing approval in the form of electronic file (PDF) online, compared to the off-line process, have been greatly reduced. And customers can easily check and store the drawings approved by the Society. In addition, the approved drawings are supplied with security certificates to prevent forgery and alteration. And the comments related to the approval of drawings are managed online so that they can be efficiently used for class inspection and customer's work in the shipyard, by owners, ship designers, and makers.

#### **Drawing Approval**

After the approval of the drawings, drawings can be submitted in reply format so that revision drawings can be easily managed.
